**PLAINTIFFS' MOTION FOR ATTORNEYS' FEES, EXPENSES,
AND SERVICE AWARDS**

Pursuant to the Court's order granting preliminary approval of the proposed Settlement Agreement ("Settlement Agreement" or "SA"), Plaintiffs respectfully seek an Order approving Mazda Motor of America, Inc., d/b/a Mazda North American Operations and Mazda Motor Corporation's, payment to be allocated as follows: (i) \$1,900,000 for Class Counsel's attorneys' fees, which includes \$59,500.31 for Class Counsel's litigation costs and expenses; and (iii) Service awards of \$4,000 for Plaintiff Duffy and \$2,500 for each of the three Class Representatives (\$11,500 total).
